

Dear Parents/Guardians:

Beginning September 5, 2019, the Golden Backpack Program, Inc. will distribute sacks filled with weekend food to participating children. The weekend food consists of food for two breakfasts, two lunches including vegetables and fruit, plus snacks and a treat for the participant. The food is distributed Thursday mornings to your child’s classroom. The food will be packed in a plastic sack and will fit in the child’s own backpack. If you wish your child (or children) 18 years or younger to participate in this program, please complete the information below and return to your child’s teacher. Forms can be turned in throughout the school year. The Golden Backpack Program is completely privately funded to the family and school. The food is free and you may include siblings that are not in school.

You may either receive the weekly sacks or choose to join our Fresh Food Co-op. We receive edge food from Whole Foods, Trader Joe’s and Sprouts. It includes fresh produce and fruit, dairy, prepared items and shelf-stable foods that is near or past the sell-by date while still retaining solid nutrition. In order to access 3 days of food per week for your family, you must be a member. Membership cost is \$15/month or six (6) hours of volunteer time per month. Please make your choice of either sacks or access to the Fresh Food Co-Op.
